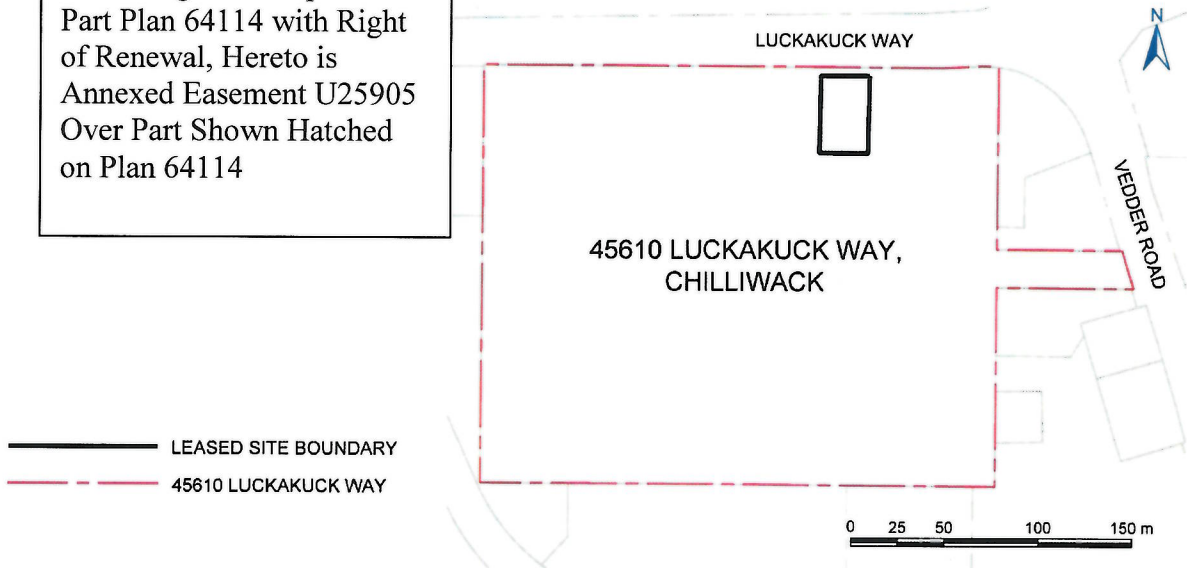


Requirements and Conditions

Schedule C

Substances and Uses

Substances evaluated in soil for commercial land soil use:

To meet numerical standards prescribed for defining whether a site is contaminated:

- Antimony, arsenic, barium, beryllium, cadmium, chromium, cobalt, copper, lead, mercury, molybdenum, nickel, selenium, silver, tin, uranium, and zinc;
- VPHs, LEPHs and HEPHs;
- Benz[a]anthracene, benzo[a]pyrene, benzo[b]fluoranthene, benzo[k]fluoranthene, dibenz[a,h]anthracene, indeno[1,2,3-cd]pyrene, naphthalene, phenanthrene, and pyrene;
- Benzene, ethylbenzene, toluene and xylene; and
- MTBE (methyl tert-butyl ether).

Substances evaluated in vapour for commercial land vapour use:

To meet numerical standards prescribed for defining whether a site is contaminated:

- Benzene, 1,3-butadiene, chloroethane (ethyl chloride), chloroethene (vinyl chloride), chloroform (trichloromethane), chloromethane (methyl chloride), n-decane, 1,2-dibromoethane (ethylene dibromide) (EDB), 1,1-dichloroethane, 1,2-dichloroethane, 1,1-dichloroethene (1,1-dichloroethylene), 1,2-dichloroethene, cis (1,2-dichloroethylene, cis), 1,2-dichloroethene, trans (1,2-dichloroethylene, trans), ethylbenzene, n-hexane, isopropyl benzene (cumene), methylcyclohexane, methyl tert-butyl ether (MTBE), naphthalene, tetrachloroethylene (PCE) (PERC), tetrachloromethane (carbon tetrachloride), 1,1,1-trichloroethane, 1,1,2-trichloroethane, trichloroethylene (TCE), 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, toluene, VPHv, and xylenes, mixture.


Substances evaluated in water for drinking water use:

To meet numerical standards prescribed for defining whether a site is contaminated:

- Aluminum, antimony, arsenic, barium, boron, cadmium, chromium, copper, lead, lithium, magnesium, mercury, molybdenum, selenium, sodium, uranium, zinc;
- Methyl tertiary butyl ether (MTBE);
- VHW₆₋₁₀, EPHW₁₀₋₁₉;

- Dichlorobenzene, 1,2-, dichlorobenzene, 1,3-, dichlorobenzene, 1,4-, monochlorobenzene
- Dichloroethane, 1,2-, tetrachloroethylene (tetrachloroethene, 1,1,2,2-), trichloroethylene (trichloroethene, 1,1,2-),
- Dichloromethane (methylene chloride), tetrachloromethane (carbon tetrachloride), trichloromethane (chloroform);
- Benzene, ethylbenzene and toluene; and
- Acenaphthene, acridine, anthracene, benzo[a]anthracene, benzo[a]pyrene, chrysene, fluoranthene, fluorene, naphthalene, phenanthrene, pyrene and quinoline.
