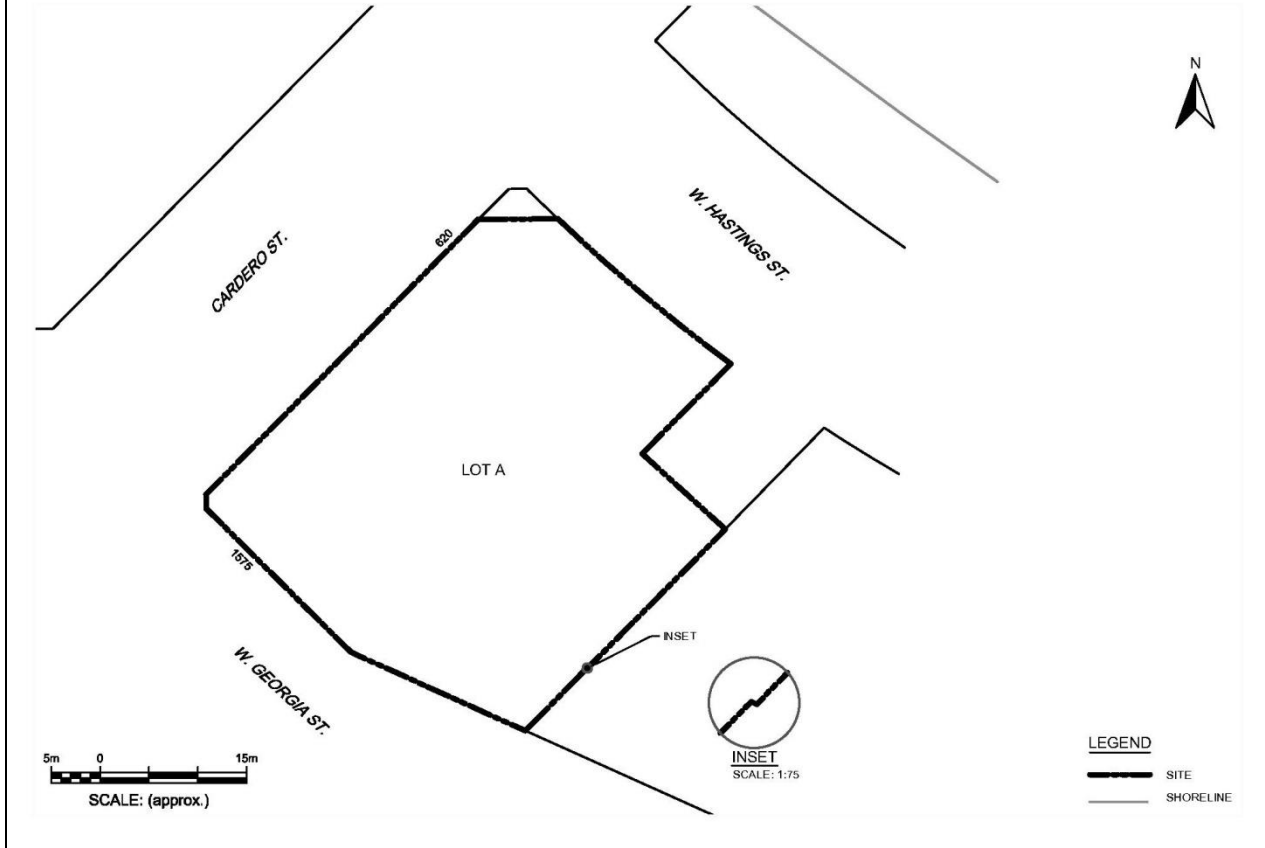

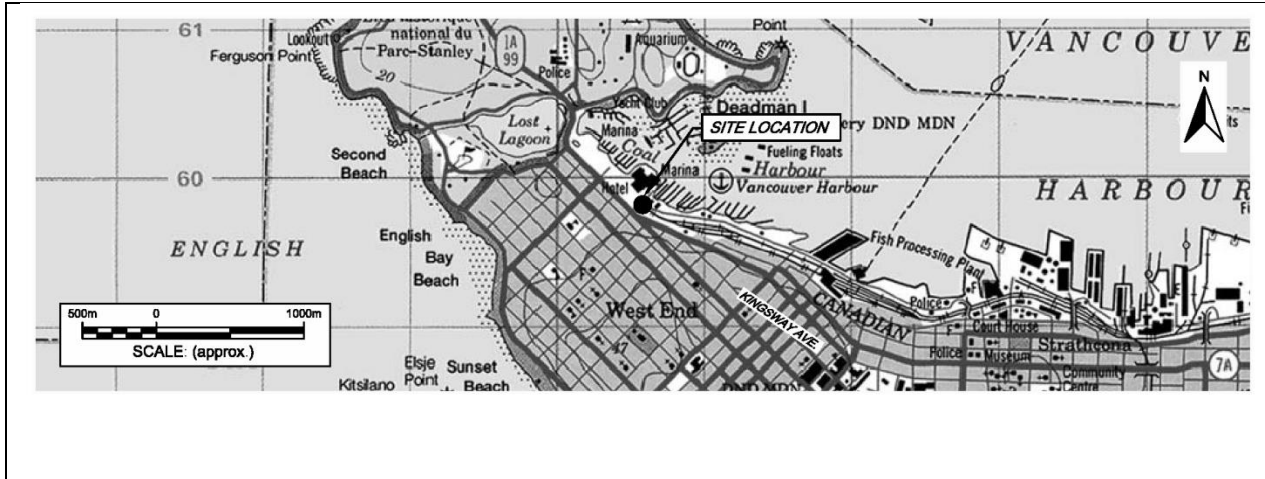
### Site Plan, Vancouver, BC
