Compensation Board regulations may be warranted. Please direct related questions to Worksafe BC.

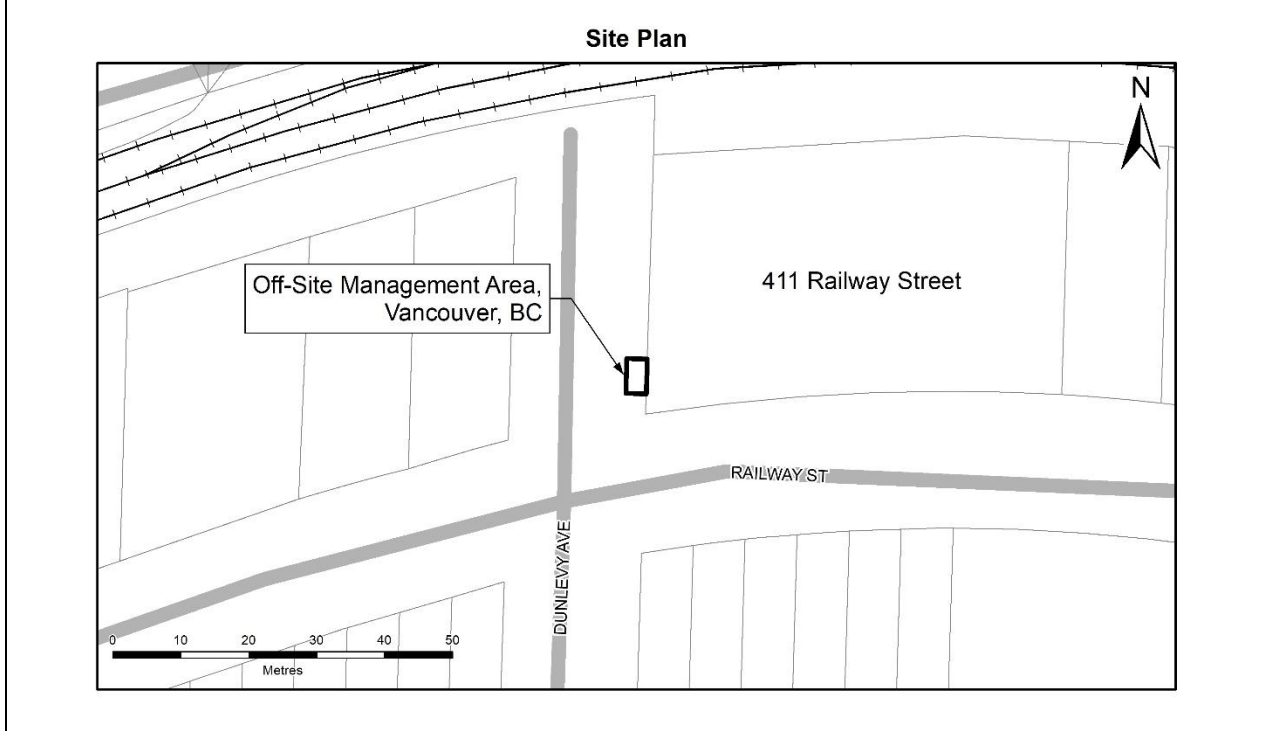

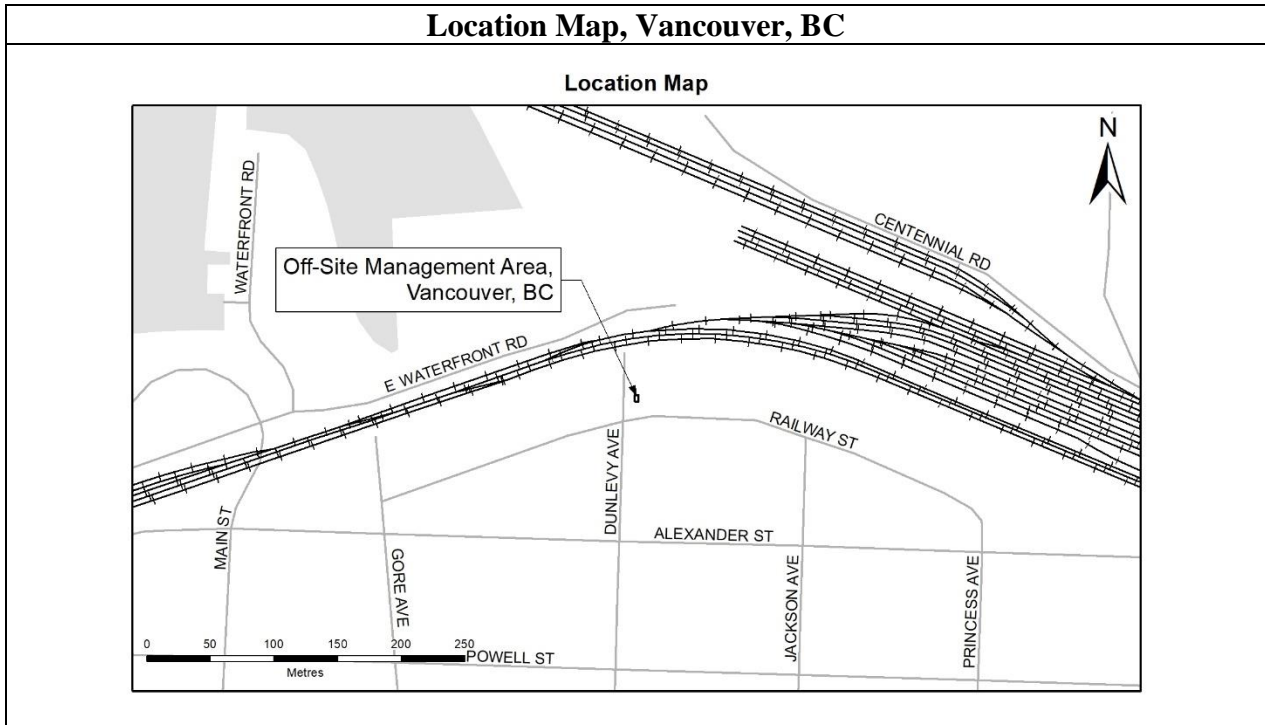
