  - (b) soil which may exceed the standards triggering a Contaminated Soil Relocation Agreement set out in Part 8 of the Contaminated Sites Regulation

and which may be encountered during any future subsurface work at the site.

4. Groundwater wells that are no longer required must be properly decommissioned in accordance with the *Water Sustainability Act's* Groundwater Protection Regulation.

Issuance of this Certificate of Compliance is a decision that may be appealed under Part 8 of the *Environmental Management Act*.

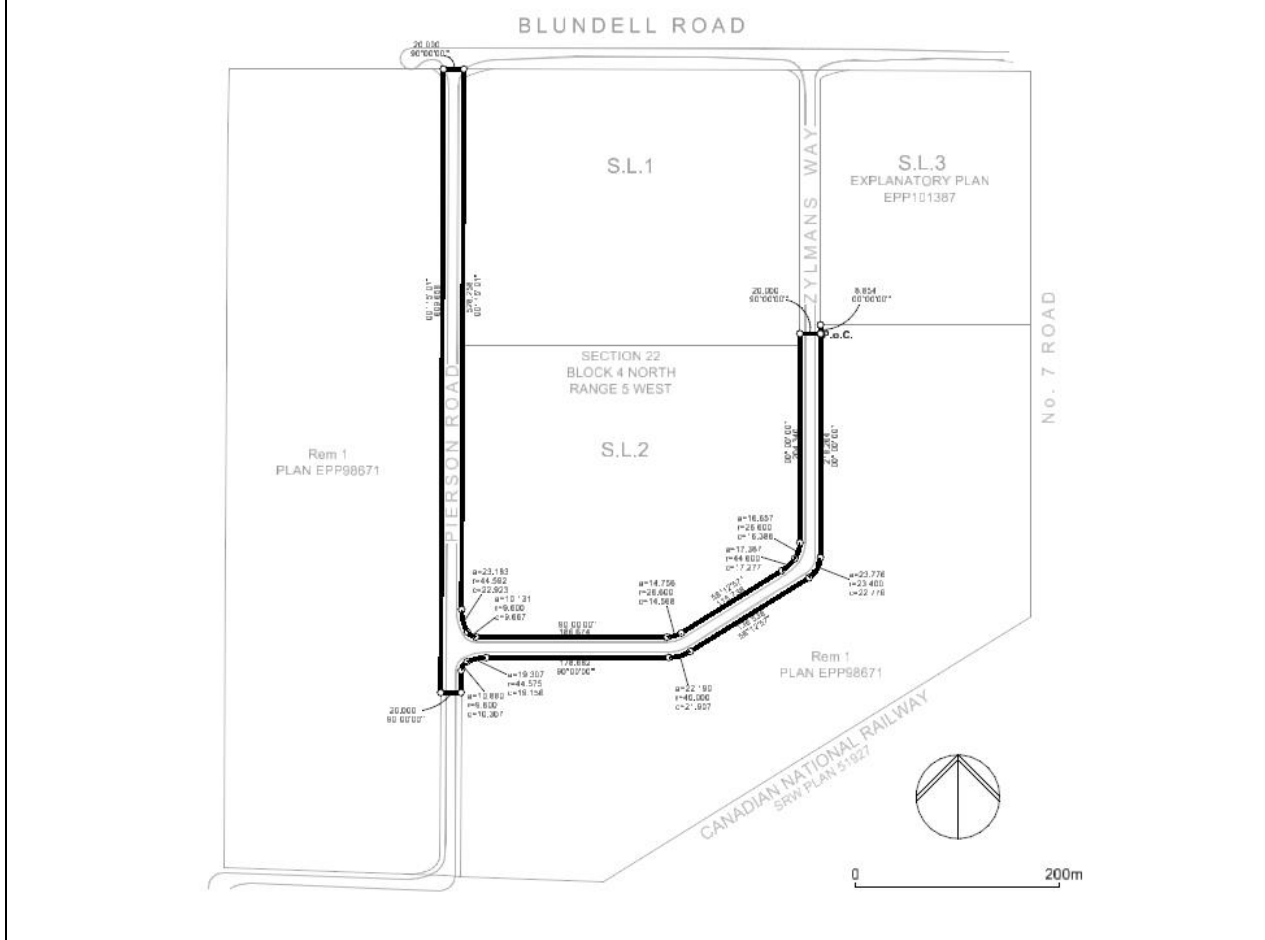

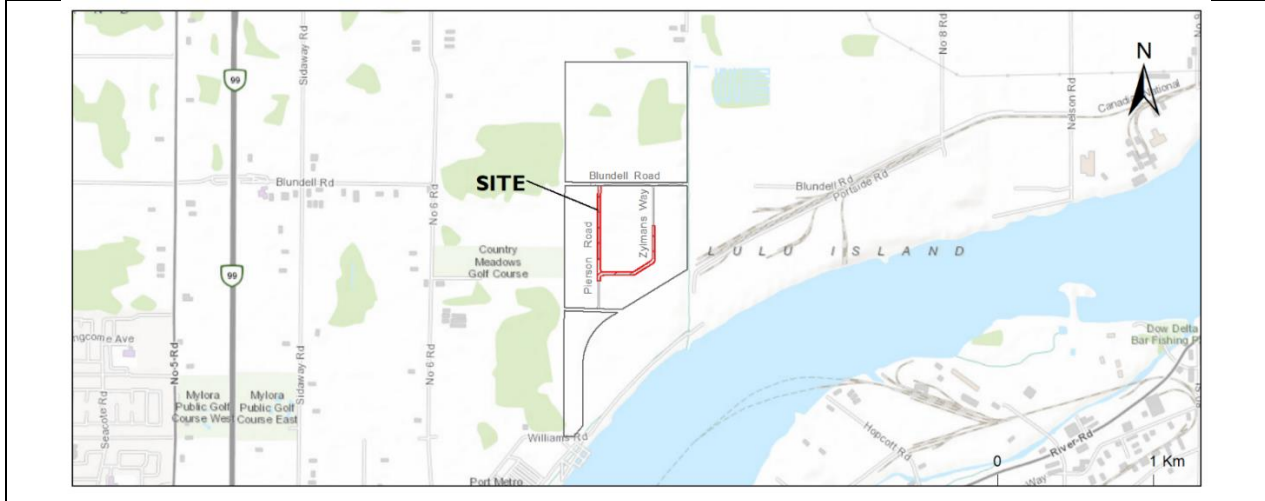

## Schedule B

### Requirements and Conditions

WHEREAS Operational Certificate 4922 – issued under the provisions of the *Environmental Management Act* (“Act”) and in accordance with the Metro Vancouver Solid Waste Management Plan – governs management of solid waste at the site AND the Director, by letter dated November 30, 2016, provided a necessary release to the City of Richmond for issuance of a development permit for the site AND an Approval in Principle was issued September 22, 2017 for the site, TAKE NOTE THAT the following requirements and conditions are hereby imposed upon MONTROSE INDUSTRIES LTD. (“responsible person”):

1. Any conflict or inconsistency between this Certificate of Compliance and the requirements imposed in the Operational Certificate must be promptly identified by the responsible person in a written submission to the Director. This Certificate of Compliance is subject to ongoing compliance with the Operational Certificate, as amended.
2. Any changes in land, vapour, or water uses must be promptly identified by the responsible person in a written submission to the Director. An application for an amendment or new Certificate of Compliance may be necessary. The uses to which this condition applies are described in Schedule C and in the site investigation documents listed in Schedule D.
3. The principal risk controls which must be present or implemented and must be maintained at the site include the following:
  - (a) Site groundwater must not be used as a drinking water source.
  - (b) The requirements of the Design, Operations and Closure Plan (DOCP) for the landfill must be adhered to.
4. If requested by the Director, the responsible person must provide a signed statement indicating whether the principal risk controls listed in clause 3 of this Schedule have been and continue to be met. This may include providing a signed statement by an Approved Professional.
5. If requested by the Director, a report signed by an Approved Professional must be submitted for review to the Director and must include the following:
  - (a) An evaluation of the presence, implementation and maintenance of institutional and/or engineering risk controls;
  - (b) Recommendations for any necessary modification of referenced plans and risk controls, along with supporting rationale; and
  - (c) Supporting documentation.
