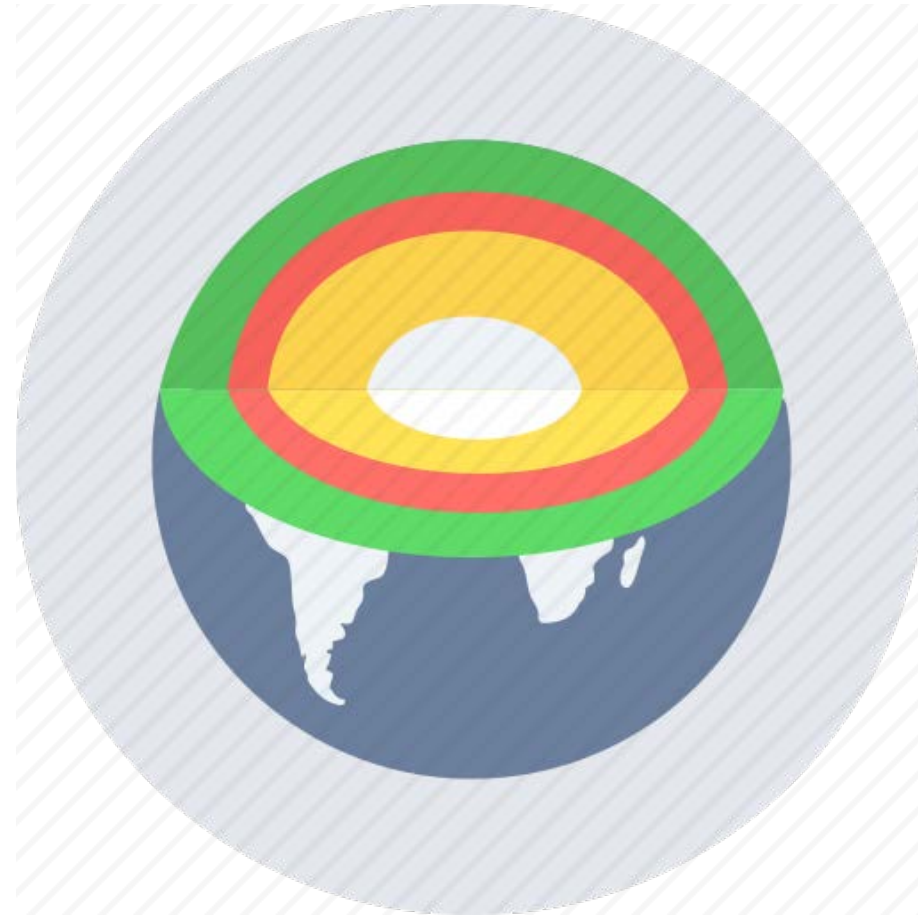
CHANGES IN LAND REMEDIATION

LAND REMEDIATION SECTION CORE BUSINESS

- **Systems & Information Management** – Site registry, enquiries, program website, software, records
- **Policy** – delivery and improvement of EMA and CSR
- **Applications Management** – Contaminated Sites Service Applications; statutory decision making
- **Society of Contaminated Sites Approved Professionals (CSAP) Oversight** – adherence to *EMA* and *PGA*; professional reliance
