**Re: Certificate of Compliance - Portion of the Highway 99 adjacent to 1450 Highway 99 between Mill Road and Clarke Drive, Squamish, British Columbia**

Please find enclosed a Certificate of Compliance respecting the site referenced above.

In addition to the conditions set out in Schedule B of the Certificate of Compliance, please be advised of the following:

1. Information about the site will be included in the Site Registry established under the *Environmental Management Act*.
2. The provisions of this Certificate of Compliance are without prejudice to the right of the Director to make orders or impose requirements as the Director may deem necessary in accordance with applicable laws. Nothing in this Certificate of Compliance will in any way restrict or impair the Director's power in this regard.
3. A qualified environmental consultant should be available to identify, characterize and appropriately manage:
  - (a) any environmental media that may be contaminated, or
  - (b) soil which may exceed the standards triggering a Contaminated Soil Relocation Agreement set out in section 40 of the Contaminated Sites Regulation and may be encountered during any future subsurface work at the site.
4. Contamination remains on lands adjacent to the site.

5. Groundwater wells that are no longer required must be properly decommissioned in accordance with the *Water Sustainability Act's* Groundwater Protection Regulation.
6. Please note that the attached Certificate of Compliance does not address obligations of employers regarding worker health and safety under the *Workers Compensation Act* and Occupational Health and Safety Regulation. Development of site-specific work procedures in accordance with Workers' Compensation Board regulations may be warranted. Please direct related questions to Worksafe BC.

Issuance of this Certificate of Compliance is a decision that may be appealed under Part 8 of the *Environmental Management Act*.

- Thence 58° 28' 31" for 53.761 metres;
- Thence 158° 10' 35" for 57.908 metres;
- Thence 205° 06' 16" for 101.876 metres;
- Thence northerly being an arc of a 320.040 metre radius curve having a radial bearing of 268° 47' 53" to the centre of said curve and a radial bearing of 252° 20' 50" to the end of said curve an arc distance of 91.890 metres;
- Thence 341° 40' 15" for 29.035 metres;
- Returning to the Point of Commencement.

The site contains part of a legal parcel depicted in an engineering drawing (22-15031-02) prepared by Keystone Environmental Ltd. on May 31, 2022.

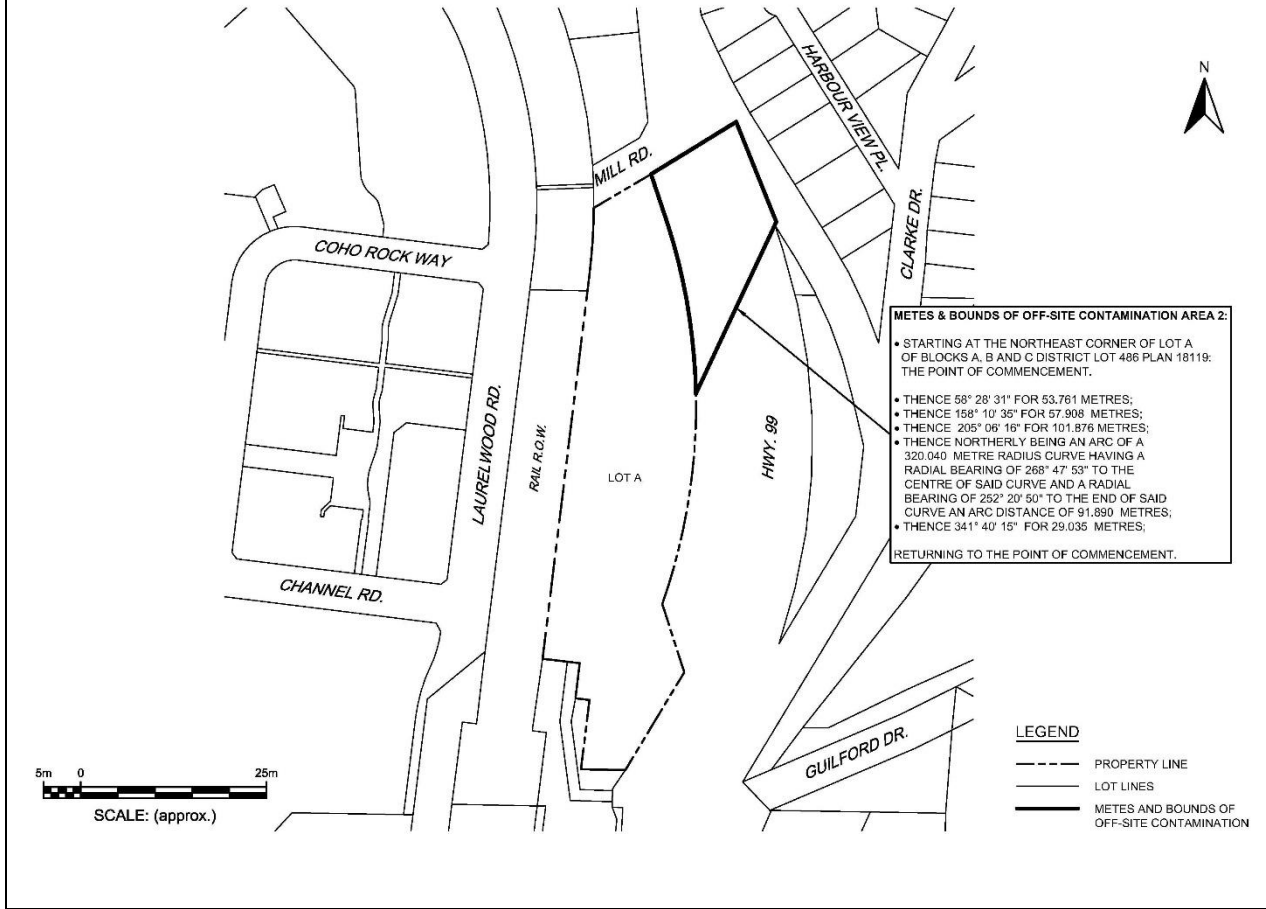

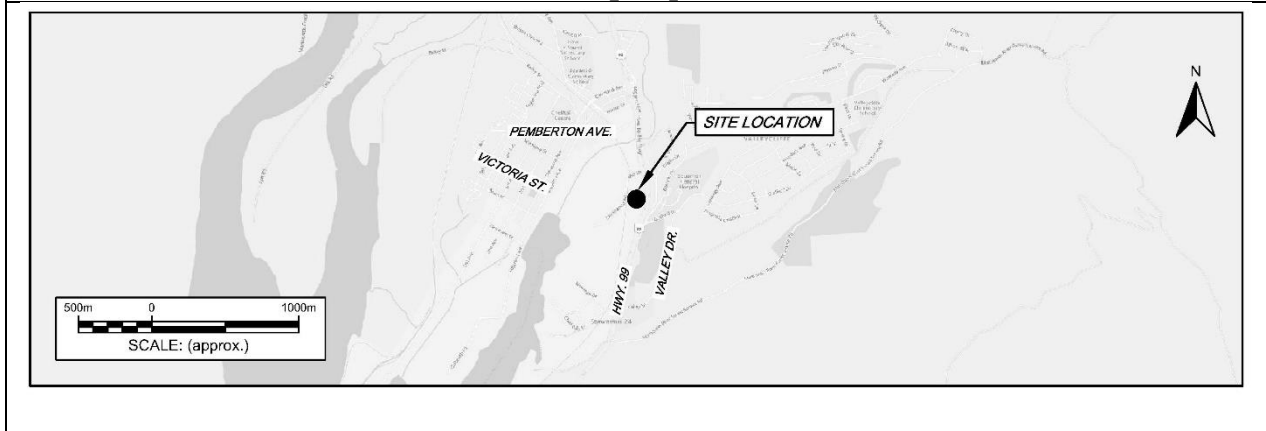
