**Re: Certificate of Compliance – City Dedication Land adjacent to 1601 Quebec Street (Formerly 1551 Quebec Street), Vancouver, British Columbia**

This Certificate of Compliance replaces the Certificate of Compliance issued May 22, 2012 for 1551 Quebec Street (Site ID 12603) for that part of the above referenced site covered under the May 22, 2012 Certificate.

In addition to the conditions set out in Schedule B of the Certificate of Compliance, please be advised of the following:

1. Information about the site will be included in the Site Registry established under the *Environmental Management Act*.
2. The provisions of this Certificate of Compliance are without prejudice to the right of the Director to make orders or impose requirements as the Director may deem necessary in accordance with applicable laws. Nothing in this Certificate of Compliance will in any way restrict or impair the Director's power in this regard.
3. A qualified environmental consultant should be available to identify, characterize and appropriately manage:
  - (a) any environmental media that may be contaminated, or
  - (b) soil which may exceed the standards triggering a Contaminated Soil Relocation Agreement set out in Part 8 of the Contaminated Sites Regulationand may be encountered during any future subsurface work at the site.

4. Groundwater wells that are no longer required must be properly decommissioned in accordance with the *Water Sustainability Act's* Groundwater Protection Regulation.
5. Please note that future site development may create preferential pathways for vapour. In this event, further assessment and remediation of vapour may be warranted.
6. Please note that the attached Certificate of Compliance does not address obligations of employers regarding worker health and safety under the *Workers Compensation Act* and Occupational Health and Safety Regulation. Development of site-specific work procedures in accordance with Workers' Compensation Board regulations may be warranted. Please direct related questions to WorkSafe BC.

Issuance of this Certificate of Compliance is a decision that may be appealed under Part 8 of the *Environmental Management Act*.

Commencing at the southeasterly corner of Lot 353 False Creek Group 1 New Westminster District Plan EPP46205, thence  $19^{\circ} 56' 33''$  along the easterly boundary of Lot 353 Plan EPP46205, a distance of 45.491 metres;

Thence, northerly and easterly on a curve to the left of radius 297.300 metres, an arc distance of 30.647 metres;

Thence,  $91^{\circ} 40' 44''$ , a distance of 2.763 metres;

Thence, southerly and westerly on a curve to the right of radius 300.000 metres, an arc distance of 31.516 metres;

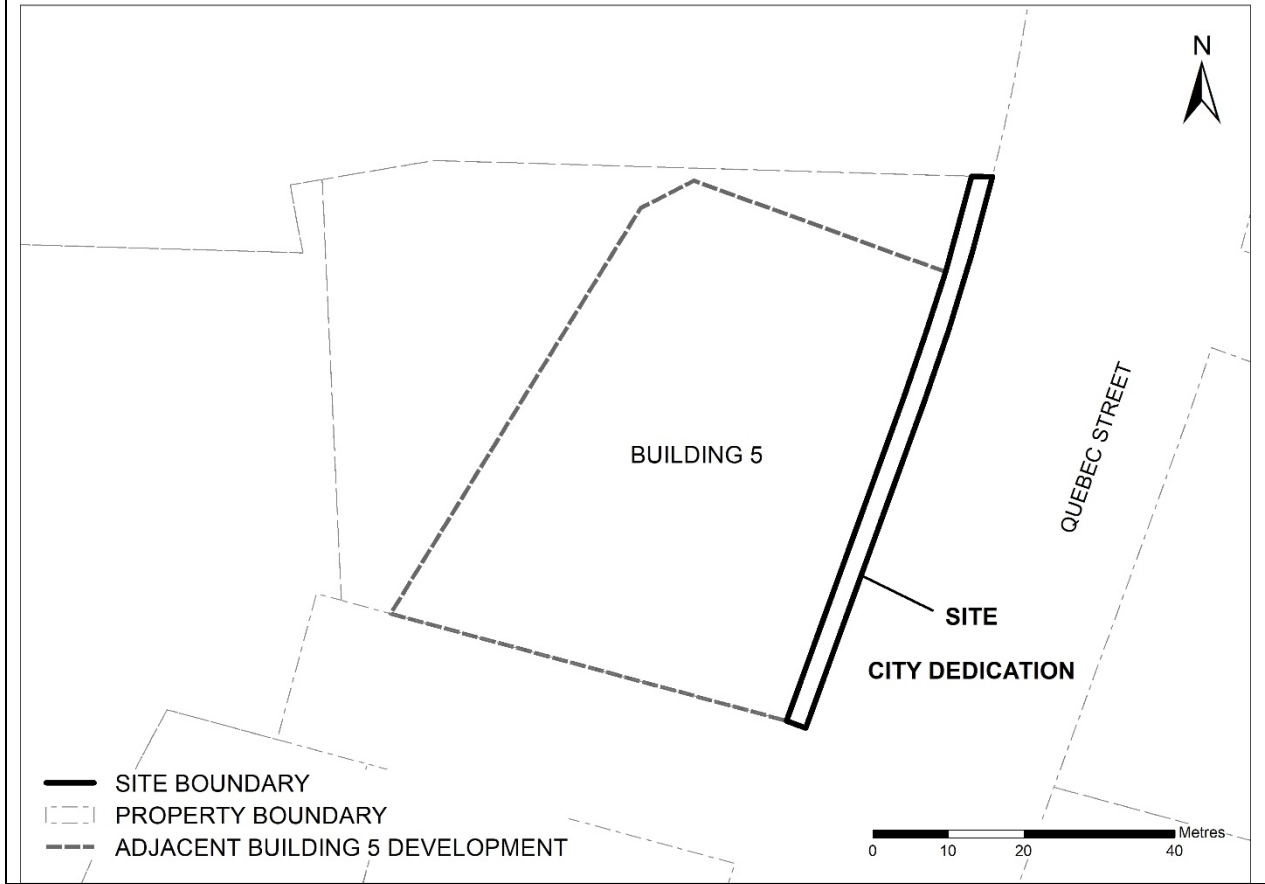

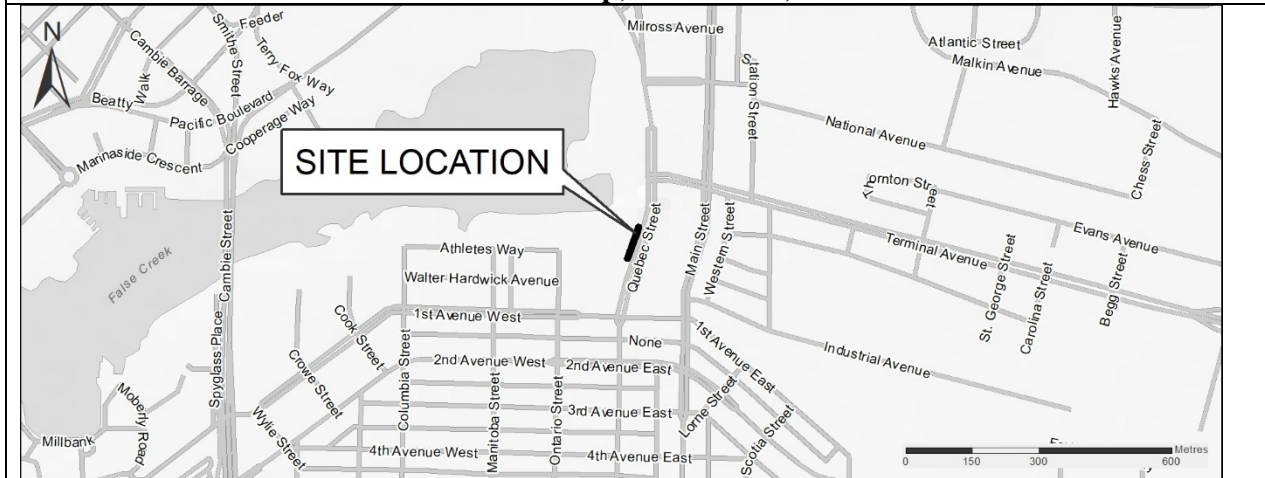

## Schedule B

### Requirements and Conditions

1. Any changes in land, vapour, or water uses must be promptly identified by the responsible person in a written submission to the Director. An application for an amendment or new Certificate of Compliance may be necessary. The uses to which this condition applies are described in Schedule C and in the site investigation documents listed in Schedule D.

The documents listed in Schedule D indicate that vapour attenuation factors were applied to meet Contaminated Sites Regulation numerical standards at and adjacent to the site. These vapour attenuation factors were selected based on assumptions about the structures, locations and depths of buildings existing or expected at and adjacent to the site. These assumptions include the following:

*(a) Current and future use of the site as a sidewalk/pathway/roadway will remain for the foreseeable future.*

Any inconsistencies that arise between the structures, locations and depths of proposed or constructed buildings adjacent to the site and the range of structures, locations and depths of buildings assumed in the selection of vapour attenuation factors in the documents listed in Schedule D must be promptly identified by the responsible person in a written submission to the Director. An application for an amendment or new Certificate of Compliance may be necessary.
