## Candidates running to represent the Parent Organizations

# Parent organization: The Association of Professional Engineers and Geoscientists of British Columbia (APEGBC)

## Michael Geraghty, P.Geo.

I am standing again as a candidate for APEGBC representative to the CSAP Board. A standards AP since 2005, I have 21 years of experience, 14 in BC. I have completed approximately 15 submissions for numerical and risk-based instruments. I regularly attend MoE workshops, CSAP professional development workshops, and federal contaminated site conferences. My service to CSAP has included membership on the Professional Development and Technical Review subcommittees, participation in the regulatory exam workshop for 5 years and being a panel member for numerous performance assessments. As Chair of the Performance Assessment Committee, I have been working towards strengthening CSAP's role in contaminated sites and make the submission process easier for Members.
