4. DRA - Will be accompanied by a PSI, DSI and Remediation Plan, but may also include a Confirmation of Remediation report.
5. SoSC - Will be accompanied by a combination of reports specific to the instrument.
- 6 If there are multiple submissions made for a site, based on a single set of reports, then each submission will require a separate SoSC report, but only a single fee of \$2000 plus GST will be required
