NOTES FOR CSAP SUBMISSION FEES:

- GST applies to CSAP submission fees unless the applicant is tax exempt.
- Full fees apply to each certification document for multiple certification document submissions.
For submissions with more than five (5) Certificates of Compliance and/or Approvals in Principle, full fees apply to each of the first five (5) certification documents and \$500 for each subsequent certification document thereafter. The full fees will apply to the certification documents with the higher value. Please note, discounted rate does not apply to Certificate of Compliance with Approval in Principle.
- For re-submission of a Deficient Submission within six (6) months following a Performance Assessment Final Findings Report, the first five (5) certification documents will be 50% of the CSAP submission fee for the same certification document, up to a maximum of \$5,000, and each subsequent certification document thereafter will be \$500.
- Re-submission of a Deficient Submission after six (6) months following a Performance Assessment Final Findings Report will be at 100% of the CSAP submission fee.

NOTES FOR CSAP REVIEW SERVICES FEES:

- GST applies to Review Services fees unless the applicant is tax exempt.
- Full fees apply to each certification document (e.g., Certificate of Compliance, Approval in Principle) for which an AP Statement or Monitoring Report is required.
- For files where monthly reports are required and made, the fee will be \$700 per report.
- For files where quarterly reports are required and made, the fee will be \$1,000 per report.

PLEASE NOTE CSAP SUBMISSIONS MUST BE ACCOMPANIED BY 2 SEPARATE CHEQUES:

- 1) CSAP submission fees must be made out in the appropriate amount to "CSAP Society".
- 2) Ministry fees must be made out in the appropriate amount to the "Minister of Finance".

NOTES FOR MINISTRY FEES:

1. GST applies to Ministry fees unless the applicant is tax exempt.
2. If there are multiple submissions made for a site, based on a single set of reports, then each submission will require a separate SoSC report, but only a single fee of \$5,000 plus GST will be required.

NOTES:

1. Reports are only reviewed as part of a Performance Assessment.
2. Appeal expenses will be paid for by the Submitter.
3. SLRA - Will be accompanied by a PSI and DSI, but may also include a Remediation Plan and/or Confirmation of Remediation report.
4. DRA - Will be accompanied by a PSI, DSI and Remediation Plan, but may also include a Confirmation of Remediation report.
5. SoSC - Will be accompanied by a combination of reports specific to the certification document.
